**TERMS & CONDITIONS**

- 1) All offers must reach the office of the Director Administration, Khyber Pakhtunkhwa Food Safety & Halal Food Authority at Ground Floor, New C & W Building, Police Lines, Khyber Road, Peshawar till **25<sup>th</sup> August 2023 till 10:00 AM**. Auction / opening of offers will be held on the same day after One (01) hour at **11:00 AM on 25<sup>th</sup> August 2023**.
- 2) Separate offer shall be submitted for each type of vehicle tyres mentioned above. Each offer must be submitted in separate sealed envelope and type of vehicle tyres must be mentioned on top of envelope.
- 3) All offers must also contain bid Security in the form of Pay order/ demand draft amounting to 25% of the total offered price (*separate for each type of tyres*) alongwith CNIC copy, Complete address, phone / cell number and tax registration certificate. Bid Security will be returned after finalization of the Auction.
- 4) Offers received without the prescribed bid security will not be considered and will be returned.
- 5) Highest offer received for each type of vehicle tyres will be recommended by the Auction Committee for approval of the Competent Authority.
- 6) All interested firms / individuals etc. will be allowed to visit the premises on **till 24<sup>th</sup> August 2023** for inspection of the Tyres.
- 7) Successful bidder will be required to deposit remaining 75% of the total offered price within Three (03) days of the award in form of pay orders/Bank draft. In case the highest price bidder fails to deposit remaining amount within Three (03) days or fails to sign the disposal contract, the bid security will be forfeited and contract may be offered to the second highest offer and so on, unless the quoted price is above reserved price.
- 8) Successful bidder will be required to deposit the Government taxes to Government Treasury
- 9) Delivery to be taken by successful bidder after full payment and will count and load the items at his own Safety, Risk, Cost and labor from the premises within Three days.
- 10) The successful bidder will be bound to clean & clear the respective area as per the satisfaction of Auction Committee if required before leaving the premises. The above said work shall be carried out in a professional manner and in an orderly manner.
- 11) Khyber Pakhtunkhwa Food Safety & Halal Food Authority reserves the right to accept or reject any or all offers before award of contract.
