TECHNICAL BID EVALUATION

The Technical Evaluation covered the following aspects:

- Quality evaluation of the offered equipment;
- Principal / OEM / Manufacturer credentials;
- Bidder's Capacity and Capability; and
- After-Sales Service.

The evaluation was conducted strictly in accordance with the Technical Evaluation Criteria set out in the Bidding Documents, and based solely on the technical bids submitted by the bidders.

As specified in the Bidding Documents (**Section VI: Qualification and Evaluation Criteria**), only those bidders/firms that met the **Qualification (Must Meet) Criteria** were considered for technical evaluation. Each bid was evaluated individually for each equipment/item to ensure maximum value for money and economy in procurement. The evaluation process was carried out exclusively on the basis of the information provided in the Bid Solicitation Documents and the bidders' submissions.

Bids that failed to meet the Qualification (Must Meet) Criteria were declared non-responsive, and their financial bids have been returned unopened in accordance with the provisions of the Bidding Documents.

The Technical Bid Evaluation Criteria carried a **weightage of 70%**. Technical bids were scored out of a **total of 100 points**, and the scores obtained by each bidder were normalized to a **70% weightage**.

Bidders/firms that secured a minimum of **70 out of 100 technical points (equivalent to 49 points out of 70 weighted points)** qualified technical evaluation. The **financial bids** of responsive and technically qualified bidders will be opened at **2:00 PM** on **16th October 2025**.

Any **grievances** relating to the technical evaluation may be submitted to the **Grievance Redressal Committee** from the date of publication of this report (**10th October 2025**) up to **14th October 2025**, in accordance with the applicable rules. Any bidder aggrieved by any act or omission of the procuring entity may file a complaint in writing to the Director General Khyber Pakhtunkhwa Food Safety & Halal Food Authority, clearly stating the specific grounds on which he feels aggrieved, and the relief or the rectification sought. The complaint shall be accompanied with certified copies of documents, including affidavits, if any, relied upon.
