TECHNICAL EVALUATION CRITERIA & RESULT

The Technical Evaluation covered the following aspects:

- Quality & Compliance (Compliance with Requirements, Additional Features)
- Delivery Period
- Company's / Bidder's Capacity and Capability (Financial Capabilities, Financial Health)
- Bidder's / Firm Experience
- Scope of Services (Warranty, Technical Support & After Sales Service and Service Center Location)

The evaluation was conducted strictly in accordance with **(Section VI: Qualification and Evaluation Criteria)** set out in the Bidding Documents, and based solely on the technical bids submitted by the bidders. Technical scores were awarded based on the offers submitted and documentary evidence provided by the bidders with their Technical Bids.

As specified in the Bid Solicitation Documents, only those bidders/ firms that met the **Qualification (Must Meet) Criteria** were considered for technical evaluation. The Technical Evaluation carried a weightage of **70%** of the total evaluation score. Bidders/ firms that secured a minimum of **70 out of 100 technical points (equivalent to 49 points out of 70 weighted points)** qualified technical evaluation.

Any **grievances** relating to the technical evaluation may be submitted to the **Director General Khyber Pakhtunkhwa Food Safety & Halal Food Authority** from the date of publication of this report **(5th March 2026) up to 6th March 2026**, in accordance with the applicable rules. Any bidder aggrieved by any act or omission of the procuring entity may file a complaint in writing to the Director General Khyber Pakhtunkhwa Food Safety & Halal Food Authority in accordance with the Khyber Pakhtunkhwa Public Procurement Grievance Redressal Rules, 2017, clearly stating the specific grounds on which he feels aggrieved, and the relief or the rectification sought. The complaint shall be accompanied with certified copies of documents, including affidavits, if any, relied upon.
