

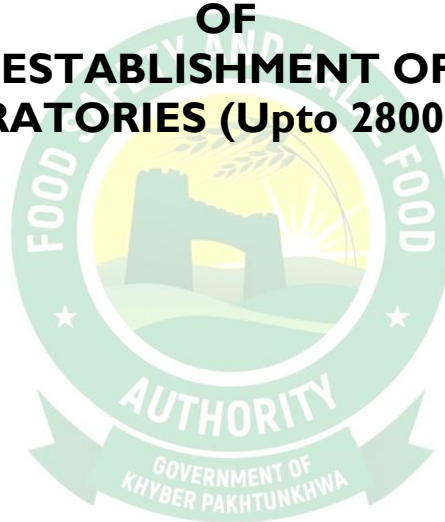

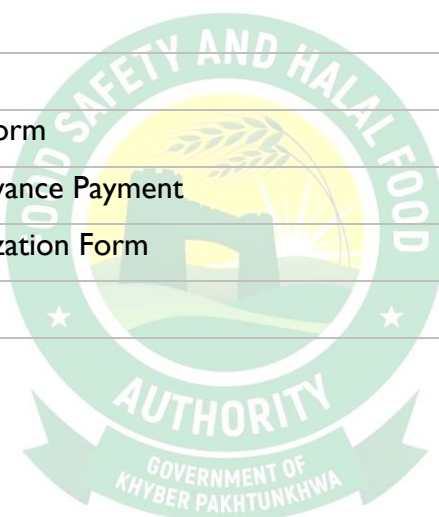

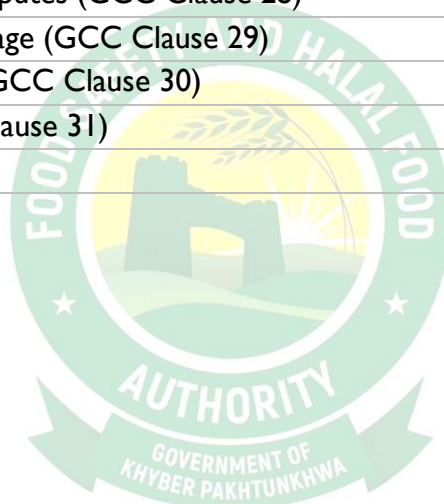

### 2. Country of Origin (GCC Clause 3)
